- A completed and signed "Health History and Authorization Form" and "Release of Liability Waiver" must be
 filled out for all campers prior to their event. The form can be filled in on-line, mailed to the camping office 2
 weeks prior to the event, or brought with you to check-in. Information related to camper's diet and other special accommodations need to be shared in advance of the first day of camp, so please indicate special needs on
 the your registration or contact camp prior to your event.
- Please share ALL important information related to your camper or yourself to allow our staff a chance to better meet your needs. We seek to provide the best possible experience and need your help in this effort. Please put this information on the Health History Form.
- There is **more information** to help in your preparations for camp in this flyer. Please read and understand the information shared here along with the information found in your Camp Welcome Letter. Other Important Information for You and your Camper

Insurance Coverage

Dakotas United Methodist Camps provide a secondary accident insurance policy for all campers. Coverage is subject to the terms and conditions of the policy.

Photo Permission

Photos and videos will be taken at camp and may be used by the Dakotas Annual Conference for camp promotions. If you would rather not have photos of you or your child used for this purpose, there is a statement you can answer on-line on the Camper Profile Sheet, or on the paper form of the "Release of Liability" form.

Safety & Transportation

Campers/Parents/Guardians are responsible both prior to and following the event for getting yourself or your camper to camp and home safely. This is also the same if you are meeting the bus to the event. In the case of some camps, this would be to a designated pick-up or drop-off point. Please follow the road signs and information in your camp event letter related to safety procedures while dropping-off or picking-up at camp. See your event letter for information related to directions, arrival and departure times, and dates. It is the responsibility of the Camp Site Director to advise each camper of any changes related to these times and locations. The event staff will go over any safety rules or procedures while at camp. In the event of immediate travel needs after check-in, these rules and procedures should be included in your camp's welcome letter as well.

Illegal and Prohibited Items

Dakotas UM Camps do not allow the use of any illegal drugs, alcohol, fireworks, firearms, or other weapons. Camp Site staff will advise if a specialized item (such as for fishing or archery) can be allowed. No camper under 18 is allowed to possess a knife. Please check with your Camp Site Director for information concerning appropriate usage of any specialized recreational equipment for land or water. All illegal substances are strictly banned from our sites.

Anti-Discrimination Policy

Dakotas UM Camps are open to everyone. In the operation of these camps, no person, as defined by the program regulations, will be discriminated against because of race, color, age, sex, sexual orientation, disability or national origin.

Campers with Disabilities

Our camping ministry welcomes person with disabilities and is working toward full inclusion of children, youth, and adults with disabilities in camps it sponsors. Off-site and wilderness based camps present more challenges, arrangements are made on individual basis.

Call home policy for campers

Campers are allowed to us the camp phones for emergencies only. If you have questions, concerns, or need to contact your camper, please fee free to contact the campsite at any time, 24 hours a day. Our staff is happy to assist you and will deliver your message to your campers as soon as possible.

Send home policy for campers

You will be contacted if:

- * Your child is exposed to a communicable disease.
- * Outside medical attention is necessary (e.g., if we transport your child to a hospital/ Dr. office)
- * Your child is having discipline problems that jeopardize the safety of others.

When a situation occurs where the camp feels it is necessary to send a camper home due to the above listed items, the camp staff will discuss the situation with the Site Director, and also with the parent or guardians when possible. Each situation is handled on an individual basis. The Site Director (or Director of Camps and Retreats in the absence of the Site Director) reserves the right to make a final decision should it be necessary. If it is determined that the camper is not able to stay, the parent(s) is(are) notified and a time arranged for the camper to be picked up. The camper is notified that he/she will be going home at least one hour prior to the arranged pick up time. The Director of Camps & Retreats is also notified when a camper is not able to stay for the full camp time.

Cell phone Policy for Campers

If a camper arrives with a cell phone, the camp staff will hold the cell phone until the end of camp. In the case of an emergency, the camper may receive permission to call home from a camp phone. There are cell phones allowed for Storm Mountain's Focus camp because that is a photography camp and they can use the camera function on the phone.

Insect Bites & Ticks

Mosquitos, flies, and other biting critters are abundant in the outdoors of our camps. For this reason we suggest that you send non -aerosol bug spray with your kids to camp.

Lyme's Disease

Lyme's Disease, carried by deer ticks, is a concern when you are outdoors. While we will do what we can to protect your child from deer ticks, it is ultimately your responsibility to be vigilant about possible signs once your child returns home. In Case of Bad Weather

The safety of our camp attendees is important to us. In case of bad weather, the site director and staff will move campers and guests to the storm shelters on the premise. Please do not call the location as we want to keep the phone line available and take care of our campers. We will notify parents when appropriate.

Non-Discrimination Statement
